

# User Instructions Suspended Bath Seat

#### **Intended Use**

To provide a raised bathing seating position in a standard, parallel-sided bath.

## **Safety**





Do not exceed the maximum load weight of 136 kg (21 st).



Inspect the product before use. Contact the service provider if you see any damage.

Suitable for most popular parallel-sided baths with flat top edges of equal height. Not suitable for corner baths, or baths with uneven or profiled top edges.

The edges of the bath must be strong enough to support the load and larger than 55 mm wide to support the ends of the bath seat legs.

#### MAKE SURE:


• The seat is level, correctly positioned so that you can comfortably reach the bath taps and the seat is adjusted to allow safe and comfortable use.

#### DO NOT:

Stand on any part of the product.

#### ALWAYS:

Sit towards the centre of the seat.




# **Unpacking**

Remove the packaging and check all parts carefully.



Contact your supplier immediately if parts are missing or damaged. Do not try to assemble.

# **Assembly/Installation**

Put the seat upside down on a clean surface.

Insert the four legs into the frame under the seat.

Align the holes and insert the E-clips.

# **Adjusting and Using the Seat**












Check that the seat sits safely across the bath, so that the grey parts of the legs sit fully on the edges of the bath.

If you need to adjust the width of the seat, remove the E-clips and adjust the legs to the next position. See Assembly/ Installation.

Fit the seat so that you can reach the bath taps without struggling.







Check you have assembled the seat legs correctly and that the seat sits inside the bath.

#### **Maintenance**

Inspect the product at regular intervals and before re-use for signs of general wear or damage.

Report to the supplier any suspected faults or damage and take the product out of use immediately. Check the fixings at regular intervals.

# Cleaning

Clean regularly using a general purpose, neutral detergent and warm water. Check the suitability of the cleaning product before use. Do not use abrasive cleaners or cloths as these could permanently damage the surface and invalidate any warranty.

To disinfect, wipe with a dilute bleach solution, and clean with a damp cloth.

Allow product to fully dry before using and storage.

## **Product Disposal**

Thoroughly clean this product before disposal and recycle where possible.

This product is made of metal and plastic. It can be disposed of through Local Authority Household Waste and Recycling Centres or through Local Trade Waste Collectors.



Recycle any cardboard packaging.
