NRS Handling Sling

🕂 General Safety Warning <u>/</u>

Please make sure that you read and follow these instructions carefully. Keep these instructions in a safe place for future reference.

1. INTENDED USE

The NRS Handling Sling has been designed to extend the carer's reach during a variety of moving and handling procedures – It is particularly useful to assist a person to move to the edge of a chair before standing, also for repositioning in bed where support around the torso is required. The soft lining is gentle on damaged and delicate skin whilst the dual handles provide flexibility and carer comfort.

Leg positioning: By placing the sling under the leg and holding the handles it is possible for a carer to safely reposition a person's legs in bed.



2. SAFETY

The NRS Handling Sling should not be used for lifting a person, or their legs, it is designed only as a repositioning and support aid.

3. UNPACKING

Remove the packaging and check all parts carefully. Contact your supplier immediately if parts are missing or damaged and do not try and assemble.

- Tumble dry Warm. Reduced spin, or air dry at very low temperatures.
