### Adequate information on the substances used:

- No monomers subject to Specific Migration Limit (SML) are used
- No additives subject to restriction (Specific Migration Limit or Quantitative Maximum) are used

Indicative overall migration tests, under the conditions 10 days/40°C, in the food simulants A, B and D2 show that the Overall Migration Limit of 10mg/dm² is not exceeded for this material, with a surface to volume contact ratio of 6dm²/kg.









## Adequate information on dual-use additives:

- Calcium Stearate (E470) (CAS nb 1592-23-0) is approved as a food additive (dual-use additive). It is present, as an additive, in the specified material
- Glycerol Monostearate (E471) (CAS nb 31566-31-1) is approved as a food additive (dualuse additive). It is present, as an additive, in the specified material

### Specifications on use:

- Use with hot, cold, clear, cloudy, and milk drinks
- Maximum temperature 90°C
- Storage for up to 10 days
