6.2 Vertical static load test of steps and platforms	Apply a pre-load of 200N for 1 minute then remove the load, apply a load of 2600N for 1 minute then remove load. Load shall be applied over an 100mmX100mm area centrally and evenly distributed on each step/platform/seat. Permanent deflection shall be max.0.5% of the width of the platform or the step.	Pass
6.3 Determination of friction coefficient	Apply a load F of 125N to the centre of the bottom step. Measure the minimum horizontal pulling force Z required to overcome friction and cause the product to slide. Measure the weight G of the product in Newton. Friction coefficient $\mu$ =Z/(G+F) shall be ≥0.20.	Pass
6.4 Seat Suitability Test	This test only applies to step stools with padded seats. To test the seat as suitable for use as a climbing support, place a disc with a mass of 0,1 kg and a diameter of 100 mm on the centre of the seat. Place a cylindrical mass of 2 kg with a diameter of 100 mm on the disc. Measure and record the settlement of the disc due to the 2 kg mass after 1 min. When tested, the settlement shall not exceed 10 mm.	N/A
